SECTION 1. That the Council of the City of Sharon hereby adopts the Community

SECTION 3. **SEVERABILITY:** The provisions of this Ordinance shall be severable
and, if any of the provisions hereof shall be held unconstitutional, void or
otherwise unenforceable, such shall not affect the validity of any of the
remaining provisions of said Ordinance.

SECTION 4. **REPEALER:** All Ordinances or parts of Ordinances conflicting with any
of the provisions of this Ordinance are hereby repealed insofar as the same
affects this Ordinance.

SECTION 5. **EFFECTIVE DATE:** This Ordinance shall become effective
January 1, 2013, for the fiscal year 2013.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SHARON, COUNTY OF MERCER, COMMONWEALTH OF PENNSYLVANIA conveying 44 Sharpsville Avenue from the City of Sharon to the Sharon Redevelopment Authority.

BE IT ORDAINED AND ENACTED by the Council of the City of Sharon and it is hereby ordained and enacted by the authority of the same as follows:

SECTION 1. Lot # 4A 26 and Tax ID # 71-31110

SECTION 2. Any previously enacted ordinance that is in conflict with the provisions of this ordinance is hereby repealed from and after the effective date of this ordinance.

SECTION 3. If for any reason any part of this ordinance is invalidated by a court of competent jurisdiction, the remaining portions of this ordinance shall remain in effect.


SECTION 4. This ordinance shall be effective immediately upon approval following second reading.
