AN ORDINANCE OF THE COUNCIL OF THE CITY OF SHARON, MERCER COUNTY, PENNSYLVANIA, AUTHORIZING AN AMENDMENT TO ITS FY 2011 CDBG ANNUAL ACTION PLAN BUDGET DUE TO A DECREASE IN THE ALLOTMENT OF FUND FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD).

BE IT ORDAINED AND ENACTED by the Council of the City of Sharon, Mercer County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows:

WHEREAS, the City approved the Application Budget for FY 2011 Community Development Block Grant (CDBG) Funds in the amount of \$749,318; and

WHEREAS, HUD approved FY 2011 CDBG funds to the City of Sharon in the amount of \$627,371; and

WHEREAS, the approved 2011 CDBG Budget must reflect a decrease in the amount of \$121,947; and

WHEREAS, the decrease amount of \$121,947 will come from various Line Items as follows:

WHEREAS, this Line Item Decrease will not result in significant changes in the Program's Delivery of Services.

SECTION 1: AMENDMENT The Council of the City of Sharon, Pennsylvania hereby authorizes an amendment to its FY 2011 CDBG Annual Action Plan Budget in a decrease amount of \$121,947 as follows:
