

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SHARON, COUNTY OF MERCER, COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE CONVEYANCE TO THE REDEVELOPMENT AUTHORITY OF THE CITY OF SHARON OF ALL THE CITY'S RIGHT TITLE AND INTEREST IN AND TO THE VACATED PORTION OF VINE AVENUE BETWEEN SILVER STREET AND PITT STREET FOR AND IN CONSIDERATION OF ONE DOLLAR.

BE IT ORDAINED AND ENACTED by the Council of the City of Sharon and it is hereby ordained and enacted by the authority of the same as follows:

- SECTION 1. CONVEYANCE: The proper City officials are herewith authorized and directed to execute and deliver to The Redevelopment Authority of the City of Sharon a special warranty deed for all of the City's right title and interest in and to the vacated portion of Vine Ave between Silver Street and Pitt Street for and in consideration of (\$1.00) one dollar.
- SECTION 2. SEVERABILITY. The provisions of this Ordinance shall be severable and, if any of the provisions hereof shall be held unconstitutional, void or otherwise unenforceable, such shall not affect the validity of any of the remaining provisions of said Ordinance.
- SECTION 3. REPEALER. All ordinances or parts of ordinances conflicting with any of the provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.
- SECTION 4. EFFECTIVE DATE. This Ordinance shall become effective ten (10) days after final passage.
