- Highland Road Pavement Repairs Project – Mr. Fiscus is asking Council to reject the bids of approximately \$39,000 for this project. The Public Works Department requested the opportunity to put a patch on the roadway. It would be much cheaper. It is uncertain how long it will work but would like to try.
